All right. This took me about 90 minutes to do 108 pages, and it's not going to get easier, I don't think.

I've finally figured out why bulk archive doesn't work 100% ... we get rate limited by Akamai. Bulk archive goes too fast. I resorted to doing the archiving 1-by-1. It's not too slow once you get a rhythm (gonna get you), but tedious since I waited until the page was definitely archived before hitting the next.

The bulk archive missed four files, highlighted in yellow in the attached spreadsheet. I found three of them stuck in the queue for archiving state (so at least that fails gracefully).

## Clean Power Plan Outreach Summary

### Proposed Federal Plan and Model Rules for the Clean Power Plan

As part of the comment period on the proposed Federal Plan and Model Rules for the Clean Power Plan, EPA is asking for information and comments from communities, states, tribes and other stakeholders. EPA has held several public hearings throughout the U.S. in different cities to obtain input before the comment period closes on January 21, 2016.

In addition, EPA held a series of teleconferences about the design of the Clean Energy Incentive Program (CEIP). These teleconferences, held in November/December 2015, have offered a variety of interested parties and community members the opportunity to share their ideas about the CEIP. Written comments about the CEIP can also be submitted through December 15, 2015, for those who missed the teleconferences.

Beginning in October 2015, the agency hosted trainings on the proposed Federal Plan and Model Rules and CEIP in Las Vegas, NV for tribes and in Port Arthur, TX for communities. A second community training will be held December 15-16, 2015 in Washington, DC and additional tribal trainings are planned for December 7-8 in Farmington, NM and December 9-10 in Tuba City, AZ. More information about registering for these events is below.

In the coming weeks, EPA regional offices will be connecting with communities about the proposed Federal Plan and Model Rules, including sharing information about the CEIP. These

meetings, webinars, and teleconferences continue the Agency's efforts to solicit feedback and comments from communities about these actions that would reduce carbon pollution from existing power plants across the nation.

## Developing carbon pollution standards under the Clean Air Act

The Clean Air Act lays out distinct approaches for new and existing sources under Section 111: a federal program for new sources and state programs for existing sources. EPA is using its authority under section 111 of the Clean Air Act to issue standards, regulations or guidelines, as appropriate that address carbon pollution from new and existing power plants, including modifications of those plants. This section of the Act establishes a mechanism for controlling air pollution from stationary sources.

Section 111 (b) is the federal program to address new, modified and reconstructed sources by establishing standards.

Section 111 (d) is a state-based program for existing sources. The EPA establishes guidelines. The states then design programs that fit in those guidelines and get the needed reductions.

## Reducing carbon pollution from the power sector

In the Clean Air Act, Congress recognized that the opportunity to build emissions controls into a source's design is greater for new sources than for existing sources, so it laid out different approaches to set the two types of standards.

On September 20, 2013, EPA [proposed carbon pollution standards](#) for power plants built in the future and kicked off the process of [outreach](#) with states, stakeholders and the public to establish carbon pollution standards for currently operating power plants.

On June 2, 2014, EPA, under President Obama's Climate Action Plan, proposed a commonsense plan to cut carbon pollution from existing power plants. [The Clean Power Plan](#) will maintain an affordable, reliable energy system, while cutting pollution and protecting our health and environment now and for future generations.

On October 28, 2014, EPA issued a [supplemental proposal](#) to the Clean Power Plan to address carbon pollution from affected power plants in Indian Country and U.S. territories.
